- Extensive experience coordinating with local, state, and federal governmental agencies and is well acquainted with regulations as applicable for natural resources issues in the state of Indiana. His career at Indiana Department of Natural Resources provides him a unique understanding and perspective for environmental issues and permitting with DNR, IDEM, and the Corps of Engineers. During his time at DNR Division of Soil Conservation, as Division Director he oversaw the division's responsibility for providing state wide storm water inspections, training all staff at all 92 Soil and Water Conservation District to complete inspections and worked closely with Indiana Department of Environmental Management to update and revise Rule 5 storm water rule.
- Developed the watershed-based river enhancement portion of the \$1.1M Lake and River Enhancement program as Assistant Director of the Division Soil Conservation, Indiana Department of Natural Resources.
- While at the city of Westfield, for over 7 years he managed the city's storm water program including inspection and plan review staff. He also was responsible for the environmental aspects of the US 31 project in Westfield/Washington Township, working closely with INDOT and its prime consultant and subcontractors through the design phase and then with contractors and subs through the construction phase. He managed and coordinated a \$60 million city park project that covered 360 acres and involved five different design consultants, an environmental permitting consultant, with more than eight contractors working on site at one time during construction. For more than 10 years, he managed the design review, environmental permitting, and inspection of hundreds of new developments with a small staff of inspectors and a plan reviewer.
